These ordinances have to be submitted to the Chhattisgarh Private University Regulatory Commission (CGPURC) and are recommended for approval by the Board of Management and subsequent Governing Body.

NEP-2020 aims to transform India's education system by introducing several reforms in curriculum, teaching methodologies, assessment strategies, and the overall academic structure to make education more holistic, inclusive, and aligned with global standards. The key areas of focus in the proposal are:

- 1. Alignment with NEP-2020 Guidelines
- 2. Curriculum Revisions
- 3. Language and Multilingualism
- 4. Technology Integration
- 5. Faculty Development and Training
- 6. Assessment and Learning Outcomes
- 7. Inclusive Education
- 8. Administrative and Governance Changes

Resolution:

The Academic Council unanimously approved the proposal for the implementation of NEP-2020 from the 2024-25 academic session, and the necessary steps will be taken to ensure a smooth transition.

# Agenda Item No 12: Application for Four Year Integrated Teacher Education Programme (ITEP).

Discussion:

MATS School of Education proposed in the BoS to start a new course as per the NEP guidelines: the Four-Year Integrated Teacher Education Programme (ITEP), and the BoS approved the proposal. Recognizing the necessity for teachers to receive training in both high-quality content and pedagogy, as emphasized in NEP-2020 [Para 5.22], teacher education is set to gradually transition into multidisciplinary colleges and universities by 2030. In alignment with this forward-thinking vision, we have submitted an application to the National Council for Teacher Education (NCTE) to initiate the Four-Year Integrated Teacher Education Programme (ITEP).

The proposal underscores our commitment to enhancing the quality of teacher education by integrating multidisciplinary approaches, thereby ensuring comprehensive training for future educators.

Agenda Item No 13:

Implementation of Legal Education Reforms and Curriculum Update (BCID-0468-2024).

Discussion:

MATS School of Law proposed a letter issued by the Bar Council of India (BCID-0468-2024) (LE Circular-06/2024), which pertains to the comprehensive implementation of legal education reforms, including the mandatory guidelines, norms, and rules of legal education (BCI:D:468/2024, Date: 20.05.2024). In the Board of Studies, the circular guidelines issued by the BCI were approved by the BoS, integrating these directives at the departmental level.

Key resolutions included the compulsory integration of mediation into legal education, as mandated by government and judiciary directives. Additionally, in alignment with the nation's evolving legal framework, it was resolved to incorporate three new enactments—the Bharatiya Nyaya Sanhita, 2023, the Bharatiya Nagarik Suraksha Sanhita, 2023, and the Bharatiya Sakshya Adhiniyam, 2023—into the curricula of universities and legal education centers, commencing in the academic year 2024-2025.

Resolution:

The members of the Academic Council unanimously suggested this to ensure meticulous adherence to and maintenance of the circular standards issued by the BCI, ensuring academic supervision and oversight.

Agenda Item No 14: Promote Indian

Promote Indian Knowledge System (IKS) in course curriculum.

Discussion:

Mr. Gokulananda Panda – Registrar has presented the proposal to integrate and promote the Indian Knowledge System (IKS) within the university's course curriculum for review and approval. The Indian Knowledge System, rooted in ancient Indian philosophies, sciences, and cultural traditions, offers rich insights and methodologies across a wide range of disciplines. This initiative aligns with the broader goal of preserving, promoting, and disseminating India's rich cultural heritage while ensuring that students gain a deeper understanding of the world from diverse perspectives.
