Discussion:

Shri Gokulananda Panda – Registrar has presented this proposal for approval of revised Self Learning Materials (SLM) for the following Seven (07) programmes and Two (02) new programmes for submission to UGC-DEB in compliance with the observations raised under the UGC (ODL and Online Programmes) Regulations, 2020:

The above **revised programmes** were earlier submitted to UGC-DEB for recognition under the entitled category. During the scrutiny, the DEB observed deficiencies in the format and structure of the Self Learning Materials (SLMs) submitted, particularly with respect to Annexure VI and Annexure VII of the UGC (ODL Programmes and Online Programmes) Regulations, 2020.

The Academic Council reviewed the compliance work undertaken by the MATS Centre for Distance and Online Education (MCDOE). The following points were noted:





- **Revised and New SLMs** have been developed entirely *in-house* by the subject faculty under the supervision of the respective Heads of Departments.
- The structure, pedagogy, and delivery mode of the SLMs strictly adhere to the parameters laid down under Annexure VI (Quality Assurance Guidelines of Learning Material) and Annexure VII (Preparation and Format of SLMs) of the UGC Regulations.
- Each SLM includes print-based modules, online content links, learning objectives, learning outcomes, and end-of-unit assessments.
- Statutory approval for these **Revised SLMs** was obtained on **March 22nd, 2025**, and the materials have been uploaded to the LMS platform <https://lms.matsuniversityonline.com>
- All programmes meet the required standards for ODL delivery and are compliant with the CBCS system and university regulations.

Resolution:

After due deliberations, the Academic Council unanimously resolved the proposal regarding the revised and new Self Learning Materials (SLMs) for the above-mentioned Nine (09) ODL programmes.

Authorize the Registrar and Director, MCDOE, to submit these revised materials and compliance documents to the UGC-DEB for further processing. The details shared were noted by the members.
