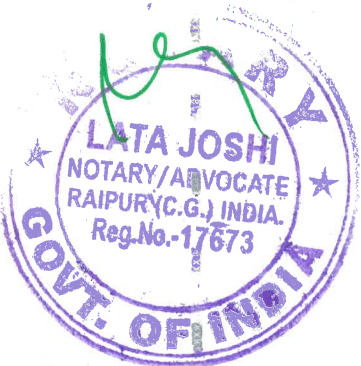

 - Appointment of requisite number of full-time dedicated faculty exclusively for above mentioned ODL/ online programmes as stipulated under Annexure-IV of UGC (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 (including its amendments from time to time).
 - Arrangement of regular assignments to enrolled candidates and their evaluation/feedback.
 - The examination system shall be proctored to ensure transparency and security.
 - Model curriculum framework/model curriculum and credit framework as defined by AICTE.
