- b. Availability of good quality Self-Learning Material/E- Learning Material and regular updating of Learning Material from the perspective of improving quality and learner support.
- c. Appointment of requisite number of full time dedicated faculty exclusively for above mentioned ODL/ online programmes as stipulated under Annexure-IV of UGC (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 (including its amendments from time to time).
- d. Arrangement of regular assignments to enrolled candidates and their evaluation/feedback.
- e. The examination system shall be proctored to ensure transparency and security.
- f. Model curriculum framework/model curriculum and credit framework as defined by AICTE.
