Marketing Management and Human Resource Management are elective specialisations within the CBCS structure and are not part of the programme nomenclature. Hence, the nomenclature used in the ODL application fully matches the Statutory Body-approved nomenclature.</p> <p>B.Sc.: The University offers B.Sc. (Combination of 3 Subjects) – General in conventional mode as well. The subject combination approved under the University's Revised Ordinance 117 is:</p> <ul style="list-style-type: none"> • Chemistry • Biology • Zoology <p>The term "B.Sc." used in the degree certificate is the nomenclature as per the Ordinance, whereas the detailed title—B.Sc.
